NEMI Teas is a London-based tea company that offers a variety of Organic & Fairtrade tea blends as loose tea and in plastic-free, biodegradable teabags. The company is also a strong believer in creating positive change through business and provides employment to refugees to help them better integrate in the UK.

It provides work experience to refugees which allows the refugees to boost their English skills, regain confidence and work on skills required to enter the UK job market. Peace and reconciliation



Online hatred and digital violence are currently silencing half of our society, drawing people out of the online space that has become an integral part of the public debate. HateAid was founded in 2018 and supports those affected by digital violence through emotional support as well as security and communication counselling. It enables those affected in taking (civil) legal action against perpetrators and thus provides them with access to justice while covering the costs.

As part of its advocacy work, HateAid advises the judiciary and law enforcement agencies in Germany and other European countries on how to set the appropriate framework to curb digital violence. Hogan Lovells created a legal opinion on the legal limits of collecting IP addresses for fighting online hate. "In our search for an expert who understands complex technical issues and does not shy away from unresolved legal questions, we found what we were looking for in Mr. Kuhlmann, who then provided us with reliable recommendations for action." HateAid supported more than 800 victims through counselling and enabled almost 80 victims to file more than 400 criminal complaints and more than 80 litigation cases.

Supporting young women and girls

ybi Youth Business International



YBI is a global network of expert organisations supporting young people to start, grow and sustain their businesses, create jobs and strengthen communities. HL BaSE worked with YBI alongside our corporate clients to provide pro bono legal advice for finalists of YBI's Young Female Entrepreneur of the Year Award. The Award 2020 was a celebration of incredible female entrepreneurs and the culmination of YBI's five-year Youth Business Europe programme with Citi Foundation. Volunteer lawyers from across Europe, worked with the finalists on a legal needs analysis and where needed follow up legal advice.

Over 26,000 young entrepreneurs across Europe have been supported to grow their business, create jobs, as well as invest in and strengthen their local communities. The 2X Challenge was launched in June 2018 as a major new commitment of the development finance institutions (DFIs) from the G7 countries to unlock resources that will help advance women's economic empowerment and gender equality. These DFIs have since been supporting investments and initiatives that provide women in developing countries with access to leadership opportunities, quality forms of employment, finance, enterprise support, as well as products and services that enhance the inclusion or economic participation of women and girls. Since the launch, additional DFI and MDB members have joined to expand the commitment. Hogan Lovells is partnering with 2X Collaborative and has advised on issues of jurisdiction and corporate structure.

Response to COVID-19



Big Society Capital launched a £28 million Resilience and Recovery Loan Fund for social enterprises and charities affected by the Coronavirus pandemic. These frontline organisations are responding to the needs of the most vulnerable and deprived sectors of our community, and many are facing significant financial difficulties. The fund, managed by Social Investment Business ("SIB") enables social lenders to provide emergency loans to affected social enterprises and charities without requiring personal guarantees and without charging fees or interest for 12 months. Hogan Lovells advised Big Society Capital on its role as loan facility agent, security agent and lender.

"In the early phase of the pandemic, we worked with partners to create the Resilience and Recovery Loan Fund (RRLF), which allowed social enterprises and charities to access government loan schemes in a way that best suited their needs. This enabled many organisations to access critical finance to continue supporting communities during a challenging time. We needed to implement this vital facility as soon as possible after COVID-19 hit. So we were very grateful for the support of Hogan Lovells, who worked with us at speed at a time when the world was only just starting to adjust to remote working." - Hazel Peck, Senior Legal Adviser, **Big Society Capital**

Of the final **£28 million** total, the Resilience and Recovery Loan Fund **approved funding to 77 charities** and social enterprises across the UK, with **£24 million's worth of loans and over £3.9 million's worth of grants approved**.

Response to COVID-19



UnLtd is the UK's leading foundation of support to social entrepreneurs. It provides funding, advice, networking opportunities and practical support to social enterprises. UnLtd's work has been of particular importance during the COVID 19 pandemic, with social enterprises suffering heavily as a result of the economic impact of COVID 19. HL BaSE has advised members of the UnLtd network on amending their governing documents in order to be eligible for COVIDrelated grant funding, as well as providing training on mission locks and asset locks.

HL BaSE also seconded one of its own, Harry Wright to UnLtd during 2020, to work in the Investment & Delivery team which is responsible for facilitating two social finance funds. During the pandemic, Harry provided post-investment support to social enterprises across the funds, helping them to access vital support and assisting them with extra emergency grant funding. He also worked as a grant assessor for the Social Enterprise Support Fund, a £18.7m grant fund for social enterprises, which offered emergency grants of £10,000 and £300,000 to social enterprises most affected by COVID-19.

Response to COVID-19

We know social entrepreneurs offer some of the best solutions to loneliness, community resilience and our nation's long term economic, social and cultural health. But we also know they consistently face systemic barriers in the pursuit of their social missions. The advice, support and guidance provided by Hogan Lovells for social entrepreneurs in 2020 has helped to address some of those barriers. By helping social entrepreneurs access funding, by delivering on commitments to social equity by providing resource in the form of a secondment and by supporting UnLtd in the creation of a new investment fund focussing on social purpose organisations from underserved communities we are changing the shape of the system. A Beijing-based B-Corp, Smart Air promotes cost-effective, data-backed air filters as a solution to indoor particulate air pollution. It creates simple, no-nonsense air purifiers to combat the impact of air pollution in many of the world's most polluted countries including China, India, Mongolia and the Philippines. Smart Air provides open-source data and hosts educational workshops across Asia to teach people how to protect themselves from the harms of poor air quality. Smart Air participated in HL BaSE Training 2020 and the firm has advised on corporate structure and shareholding agreements in various jurisdictions including Mongolia.

Mexico-based NUUP creates market-based solutions for smallholder farmers by facilitating information flows, and promoting transparency in agricultural value chains while enabling sector-wide collaboration. NUUP provides advice to companies, small-scale producer groups and allied social organizations in the development of agrifood value chains with economic, social and environmental impact.

"We are very grateful for the support HL gave us. They helped us navigate complex contract design and develop technology and data management models that are ethical and serve farmers first. They supported Nuup with legal advice that enabled the contractual framework of a first pilot in Mexico bringing disruptive sensor and internet of things technologies to milk producers in family farms. With these technologies, producers will have daily detailed information on their ranches, which will allow them to improve their daily operations and planning. The expected effects are that they will improve their performance, their early detection of diseases, and in turn, their income. In addition, these technologies may allow improving the environmental sustainability of the farms as well as the time that the producer dedicates daily to these activities. In the context of COVID 19, these technologies become even more important by allowing the producer to receive digital advice. We implemented these pilots 6 months ago and while we still have at least 9 months to go we are already seeing initial impact in farmers improvements in reducing costs and increasing income." Futuro Forestal's vision is to create a better world with an environmental infrastructure that is economically viable and in harmony with nature. Generation Forests are permanent, and biodiverse tropical forests that are profitable and generate environmental and social benefits - forever. To plant generation forests, Futuro Forestal cooperates with forward-thinking investors interested in balancing long-term returns with environmental and social benefits, to tackle climate change and related environmental challenges. Generation Forests absorb CO2, provide habitat for wildlife (they have already seen jaguars come back!), restore degraded soils and water resources. Through the production of certified fine tropical timber, the forest generates fair employment opportunities for local communities as well as long-term returns for investors.

glassic is a German-based environmental start-up which tackles the plastic pollution in South-East Asia directly at its root cause. By introducing a reusable glass bottle system glassic changes the consumption paradigm from linear to circular. By selling drinking water in multi-use glass bottles, glassic found self-sustaining businesses as a baseline for additional actions. Through education, awareness creation as well as the consistent organization of clean-ups, the organisation aims to create long-lasting change. We are advising glassic on the incorporation of a German non-profit limited liability company (gemeinnützige GmbH), with a particular focus on corporate and tax law issues.

FEA is a non-profit domestic worker employment agency based in Hong Kong, which aims to eradicate forced labour of migrant domestic workers and disrupt the migrant labour market for good by providing ethical recruitment solutions. Since its creation 6 years ago FEA has placed over 5,000 migrant workers, and is now one of the top ten biggest employment agencies in Hong Kong. FEA participated in HL BaSE Training 2020 and was advised by a team of junior lawyers from Hogan Lovells' Hong Kong office. Hogan Lovells provided FEA with [invaluable] advice on a key service agreement between FEA and an employer who engages FEA to hire domestic helpers.
