The programme runs in London, Hong Kong and New York, ensuring that junior lawyers joining the firm are familiar with the importance of social impact to all of our clients. The programme is delivered in partnership with Ashoka, a global network of Ashoka Fellows, the world's leading social entrepreneurs. A key part of the programme is a workshop in which social enterprises can access pro bono legal support from a small team of junior lawyers who will go on to advise for the next 6 months.

affordable mobile money and broadband services in Mexico

Hogan Lovells advised on the establishment of RedConcero, S.A.P.I. de C.V. by Ashoka, a global network of changemakers, and its partner Concero Connect, L3C, a Grameen Social Business that provides affordable broadband Internet and financial inclusion. Their goal is to bring opportunity to remote and underserved areas of the world, starting in Mexico. RedConcero is a jointly-owned Mexican Mobile Virtual Network Operator that uses a share of mobile money transaction fees to help offset telecom costs and assure the long-term sustainability of these services in underserved communities and populations.

### using biometrics to protect street children

Itwillbe.org has developed an app that enables social workers to use biometrics to register and document street children. The purpose of the app is to enable undocumented individuals to prove their identity, increasing access to healthcare and education and protecting them from exploitation. Child PPa (Protection People app) was first used in India in collaboration with the NGO Don Bosco, supporting social workers in 81 centres. Over 80,000 street children go missing in India every year and enabling social workers to collect information from them can protect them from smuggling mafias, who take advantage of their lack of registry and documentation, and help them to access and monitor the social and healthcare support that they receive.

Alina Vision develops and delivers high-quality, accessible and sustainable eye care to preserve or restore sight for clients of all income groups, actively reaching out to serve those excluded from mainstream healthcare systems, particularly low-income individuals. Its work is funded using blended finance – drawing on philanthropy to address the largest risks involved in entering new markets and expanding the network, which then attracts private investment to achieve the scale and speed needed to make a difference.

# RECUP

### reducing waste in Germany

Munich-based RECUP has developed an innovative and sustainable deposit system for reusable takeaway coffee cups. It has created an app that allows users to find their nearest coffee shop and for a 1 Euro deposit 'borrow' a RECUP which can be returned to any other partnering coffee-shop, to be cleaned and reused by other coffee-lovers. RECUP has developed a consumer and supplier friendly multi-way system that has the potential to significantly reduce waste and facilitate environmentally friendly habits.

## Abianda

### supporting young women affected by gangs

Abianda supports gang-affected young women by combining a solution focused and competence based approach with participatory principles and techniques. By asking young women the right questions and offering an equal, transparent relationship it helps them to discover their own resilience and to develop the power to change their situation. Abianda provides frontline services for young women aged 11 to 24 in London, and training for professionals such as social workers, youth workers, police, health professionals and foster carers so that they may work more confidently and effectively with gang-affected young women. Hogan Lovells has assisted Abianda with its employment and commercial contracts, corporate structuring and by running a day of training on business basics for some of the young women it supports.
